PHRF-LO Certificates:

Anyone racing in Monday night Women's Racing, Tuesday night PHRF (Divisions 1, 2 or 3), Thursday night JAM (Divisions A, B or C), or any PHRF long distance race (with a few exceptions), must have a current PHRF-LO certificate. A \$25 fee (\$22 if received by April 1st), payable by cheque to NSC, is required for *all* certificates and must be included with your Race Registration form. Boats will not be scored until the PHRF application fee is received, and their form is processed. Do not leave this to the last minute! Please check the appropriate box below:

- If you had a PHRF-LO certificate in 2009 or 2010, and there are **no changes to your boat** that affect your PHRF certificate, complete the following:
